



## **Fraud Alert & Disclaimer**

**Hari and Company Investments Madras Private Limited** [successor-in-interest to the NBFC undertaking of Vivriti Capital Limited (formerly Vivriti Capital Private Limited) pursuant to the composite scheme of arrangement, approved by the Hon'ble National Company Law Tribunal, Division Bench – II, Chennai Bench ("NCLT") vide its order dated December 9, 2025] ("**Vivriti**") warns the public against fraudulent loan offers, communications, mobile applications, websites, or social media profiles (WhatsApp, Telegram, etc.) falsely claiming association with Vivriti and/or its lending partners.

It has come to our attention that certain unauthorised persons/entities have created, or may create, misleading applications, websites, digital platforms, or advertisements using Vivriti's name, logo, or brand identity and demanding advance fees, processing charges, or security deposits under the guise of loan disbursement, with an intent to mislead or defraud unsuspecting individuals. Vivriti expressly disclaims any association with such unauthorised platforms or activities, and such actions are neither endorsed nor authorised by Vivriti.

Members of the public are advised to exercise extreme caution, as such fraudulent platforms may seek to collect sensitive personal, financial, or confidential information, request unauthorised payments under false pretences or issue misleading loan sanction communications.

### **Common Scam Methods:**

Fraudulent activities come in various forms, including but not limited to:

- **Phishing/Vishing:** Deceptive emails, texts, or electronic communications mimicking legitimacy to extract personal information or prompt you to click on links or download attachments. "Vishing" involves fraudulent calls impersonating our organization to acquire personal information.
- **Loan Application Scams:** The scam involves some unscrupulous persons pass themselves off as representing or being affiliated with major banks and financial institutions, with the intent to defraud unsuspecting members of the public.
- **Bank Transfer Scams:** Fraudulent stories via phone or email urging money transfers in or out of bank accounts.
- **4. Investment Scams:** Offering or promoting high-return investments through deceptive means to elicit illegitimate money transfers via websites, apps, or social media.

- **Never Share Sensitive Information:** Vivriti will never ask for passwords, financial details, or personal data via unsolicited emails, ads, or third-party websites.
- **No Upfront Fees / Unsolicited Requests:** Vivriti does not solicit loans, collect upfront fees, or request payments through informal channels such as personal accounts, unverified links, or unsolicited communications. Any such request should be treated as fraudulent.

Vivriti does not permit collection of any fees or charges by LSPs or third parties directly from borrowers. All loan disbursements and repayments are required to be executed directly between the borrower's bank account and the regulated entity's bank account, in compliance with RBI guidelines. Requests for payments to personal or unrelated accounts are indicative of fraud.
