Summary of the proceedings of the 37th Extra-Ordinary General Meeting held on November 16, 2023

The 37th Extra-Ordinary General Meeting ('EGM') of the Company was held at shorter notice on Thursday, November 16, 2023, at 5:30 P.M. (IST) through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM") at Prestige Zackria Metropolitan No. 200/1-8, 2nd Floor, Block -1, Annasalai, Chennai – 600002, India.

The Company, while conducting the meeting through VC, adhered to the Circulars issued by the Ministry of Corporate Affairs ("MCA") and the Securities and Exchange Board of India ("SEBI") from time to time. Further, the Board of Directors had also approved an inclusion of clause with respect to inspection of books of accounts by shareholders and non-members. The Altered AOA as placed at the meeting was recommended for the approval of the Shareholders by way of Special Resolution.

Thereafter, the aforesaid matter was put to vote by way of a Special resolution, and the same was approved accordingly.


Thereafter, the aforesaid matter was put to vote by way of an Ordinary resolution, and the same was approved accordingly.
