Summary of the proceedings of the 42nd Extra-Ordinary General Meeting held on January 03, 2025

The 42nd Extra-Ordinary General Meeting ('EGM') of the Company was held on Friday, January 03, 2025, at 05:30 P.M. (IST) through Video Conferencing ("VC") at Prestige Zackria Metropolitan No. 200/1-8, 2nd Floor, Block -1, Annasalai, Chennai – 600002, India.

The Company, while conducting the meeting through VC, adhered to the Circulars issued by the Ministry of Corporate Affairs ("MCA") and the Securities and Exchange Board of India ("SEBI") from time to time. The proceedings of the EGM were deemed to be conducted at the Registered Office of the Company which was the deemed venue of the EGM. The physical presence of the members was accordingly dispensed with.

7 (Seven) members were present (including authorized representative(s)) at the meeting through VC.
